## The Thread of Gold Chronicles The Holy Sisters and Benson Phillips

## HISTORY OF THIS DISCUSSION by Nell

"The Public Square" was an Internet forum hosted by The Bereans Apologetics Research Ministry. At one time "The Bereans" contained years of debate among current and former Local Church members, but is no longer available. It was my habit during the "Bereans era" to download (copy and paste) pertinent topics which I felt it was important to keep, in the event that the other forum was no longer available. This copy/paste is very rough, containing massive HTML coding which I have attempted to clean up.

Matt Anderson was, for a time, a moderator of the Nee/Lee section on the Bereans. I did a copy/paste of the "Thread of Gold Chronicles" topic created by Matt Anderson in January 2006 to address the statements by Benson Phillips, now deceased, in the 2005 Winter Training.

On August 19, 2022, a link to Benson's remarks was posted on the Local Church Discussions forum, by an unregistered contributor. (http://localchurchdiscussions.com/vBulletin/showpost.php?p=106601&postcount=15)

This posted bitchute link containing the audio to Benson's 2005 statements, after being "live" few days, has now been blocked. https://www.bitchute.com/video/xDfjhKwnk64o/ If you missed it, some of Benson's statements from 2005 are quoted below, and there are quotes from the LSM printed version of his remarks in the 2005 Training.

Why is this important? Benson's 2005 remarks opened the door for this 2006 discussion. Matt is the son of Jane Carole Anderson. Jane wrote her testimony and published it in book form, titled *The Thread of* Gold, the Cross, God's Purpose and Me. Matt made an attempt to personally address Benson, scripturally, regarding his actions. Matt's letter to Benson is included below.

\*\*\*From Matt\*\*\*

Read Jane's experience of church discipline at the hand of Dan Williams (ficticious name). In this topic is the account of how Dan Williams outs himself by revealing his true identity in front of about 3,000 people. Dan also reveals that, after 30 years, he believes he was right to do what he did to Jane.

The format of this document is a public discussion. The speaker's name or moniker is **bold** followed by the date and time the post was entered, a line (-----), then the name of the topic. For example:

## **PREFACE**

Special Note to Local Church members: It can be shown that what Benson said at the 2005 winter training concerning my mother and others is false. Here is the applicable teaching from the Word on how an accusation against an elder (in this case, against Benson for speaking falsely) should be made:

1 Timothy 5:17-21 - Let the elders that rule well be counted worthy of double honour, especially they who labour in the word and doctrine. For the scripture saith, Thou shalt not muzzle the ox that treadeth out the corn. And, The labourer is worthy of his reward. Against an elder receive not an accusation, but before two or three witnesses. Them that sin rebuke before all, that others also may fear. I charge thee before God, and the Lord Jesus Christ, and the elect angels, that thou observe these things without preferring one before another, doing nothing by partiality.

## INTRODUCTION

Since the publication of my mother's book, **The Thread of Gold**, (www.thethreadofgold.com) there has been a significant amount of communication among those who have met (or continue to meet) with the Local Churches of Witness Lee. There have been a number of inquiries about various historical details relating to key events over the past 30-plus years.

Due to the practices of the Local Church leadership, many details about events have been covered over and the facts are not known.

This chronicle addresses matters related to the events that occurred in 1977 to which Benson Phillips recently referred in the 2005 winter training.

## **BACKGROUND**

- 1. In Chapter 1 of The Thread of Gold, an elder (aka Dan Williams) "dealt" with my mom as part of a "sister's rebellion" in 1977 in Houston, Texas. (The terms, "sister's rebellion" and "sisters' flow" have been used interchangeably over the course of the past 29 years when referring to what happened with some sisters during that period of time.)
- 2. In the 2005 winter training, Benson Phillips referred to The Thread of Gold and the "dealing" that occurred against the author (my mother) in 1977.

- 3. Benson Phillips bore false witness in the 2005 winter training when he spoke about this matter.
- 4. Benson Phillips' statements resulted in members of the body of Christ beginning to ask questions. Their questions led to the uncovering of additional facts regarding the events of 1977.

A. EXCERPT FROM BENSON PHILLIPS' MESSAGE FROM THE 2005 WINTER TRAINING

2005 Anaheim Winter Training
Crystallization-Study of the Building of God
Message 11 - Discerning the Destroyers of the Divine Building
to Remain in the Lord's Recovery of the Divine Building

## Benson Phillips:

"A factious man is a heretical (and I'm using the word >heretical' here; he may be one who is preaching heresies (heretical also means sectarian), sectarian man who causes divisions by forming parties in the church according to his own opinions.

In order to maintain good order in the church, a factious, divisive person should be refused, rejected after a first and second admonition. Brothers, we may see such onesCa brother or sister. I'd like to tell you a couple of stories in the recovery. In 1987 [sic], we had some sisters out on the west coast. They started

building up a kind of group around themselves. They were inviting sisters, and they were getting into the Word and were talking about doctrine, and they were getting clear on the church, getting clear on everything.

Then it spread to Texas. I don't know where else it spread to, but anyhow, some sisters in Texas got into the same flow. And because it had happened here in Anaheim and there in Texas, we brothers had to do something. And even Brother Lee, I remember, in a conference ... Brother Lee, he was so distraught and so grieved (I don't know what word to use). In one meeting he said, >You three holy sisters, would you stand up?' (I think he asked them to stand up.) Well, I learned a lesson there he did not mess around with factious people. And he said, >You three holy sisters,' and he asked them a question. Would you do that? Would you have the boldness to do that? Well, maybe one day you will have to do it.

Then, in Texas, let me tell you this: They had their so-called, you know, party. It really was a party. They didn't call it a party, but that's what we're talking about, a factious party, built up in the church. It may be sisters, it may be brothers, it may be young people, it may be co-workers, it may be anyone. But to form a group around yourself is factious and sectarian because it keeps others out, and you become special. That is factious. Well, this one sister that we had to deal with, she was the leader. That was over 30 years ago by now. You know what she just came out with? A book against the recovery! Was she the right kind of person? Did we do the right thing? Absolutely, we did the right thing! If she can write a book against the recovery today, that seed was in her even then. Isn't this something? Brothers, these kind of people, the factious people, those who form parties within the church, they have to be dealt with. Why? Because they are destroyers of God's building."

**Factual Correction**: Benson refers to 1987 in this excerpt but then says, "That was over thirty years ago by now". The fact is that it was 1977.

## **B. QUESTIONS RESULTING FROM BENSON'S MESSAGE**

Some who heard this account by Benson have inquired about his statements. Some have been generally interested and inquisitive about various events over the past 30 years.

## From 1/9/2006 thru 2/16/2006

- 1. Jane Anderson (my mother) received inquiries from interested members of the body of Christ who heard Benson's statements. (Jane Anderson is the person Benson was referring to as the "leader" in Texas.)
- 2. Jane Anderson responded to the questions about Benson's statements.
- 3. Jane Anderson corresponded with Sandee Rapoport about dates and about the reference to the "three holy sisters." (Sandee Rapoport is the person who was recognized as the "leader" of the "sister's flow" in Anaheim.)

## Key questions Jane was asked:

- 1. Did Jane understand the reason, as put forth by Benson in the 2005 winter training, that she was disciplined in the church in 1977?
- 2. Did Jane know what happened with the "holy sisters" in Anaheim?

# C. ANSWERS, DISCOVERIES, AND CONCLUSIONS RESULTING FROM THESE QUESTIONS

Detailed communications that support the following statements will be presented later in chronological order (in several subsequent posts).

- 1. My mom was dealt with in May 1977. Until recently she has believed that Sandee Rapoport was dealt with in the fall of 1978 (because that was when the Texas brothers announced that Max and Sandee had left the recovery and also when she heard about the end of what they referred to at that time as the California sisters' rebellion.) However, she has now discovered that her original understanding was wrong. What happened to her and what happened to Sandee Rapoport did not occur at different times. They actually occurred on the exact same weekend in separate localities. When?: Memorial Day weekend, 1977. These two events appear to have been organized in advance.
  - a. Witness Lee spoke out against the sisters' flow in Anaheim.(Sandee was requested to be at this meeting in advance of the meeting.)
  - b. The Texas brothers spoke out against a sisters' rebellion in Houston. (Jane was requested to be at this meeting in advance of the meeting.)
- 2. At the 2005 winter training, Benson presented a false witness before thousands of members of the Local Churches. His statements were also presented to more members during the subsequent video trainings:
  - a. False speaking: Benson spoke as if he was present to hear Witness Lee when he supposedly called out the "three holy sisters".

**Truth:** This statement is extremely questionable because the same weekend that witness Lee spoke out against the sisters in Anaheim (Memorial Day weekend,1977) Benson was in Houston, Texas.

b. **False speaking:** Benson claimed that Witness Lee used the terminology "holy sisters" and claimed that he called out the three sisters publicly and asked them to stand up in a meeting.

**Truth:** Witness Lee did not use the term "holy sisters." (Phillip Lee was known to have used this term.) Witness Lee did not call the three sisters out and ask them to stand up. This fact is corroborated by multiple participants in the meeting to which Benson referred.

c. False speaking: Benson claimed that the sisters' flow started in Anaheim and spread to Texas. This is not true.

Truth: There was no communication between Jane Anderson and Sandee Rapoport until after the winter

2005 training. Before this, they briefly met only one time after the Memorial Day weekend in 1977. There was no connection whatsoever between what was happening with sisters in Anaheim and my mom in Texas.

d. False speaking: My mother came out with a book "against the recovery."

**Truth:** the book is my mother's testimony of her experience of the Lord. The focus is Christ and the believer's freedom to follow Him, the Lamb of God.

D. OPEN LETTER TO BENSON PHILLIPS REGARDING OFFENSES AGAINST THE BODY OF CHRIST, OF WHOM I AM A MEMBER

## Benson.

You continue to slander my mother and others and bear false witness; therefore, I am speaking the following verse into the record before God. I am asking you to give account for your actions:

 Take heed to yourselves: If thy brother trespass against thee, rebuke him; and if he repent, forgive him.

Will you repent for bearing false witness? Your slander was public. Your repentance should match.

You should repent specifically for bearing false witness on the points mentioned above. Your repentance should be made to the members of the Local Churches, to my mother, and to the ones you referred to as the "three holy sisters."

You may contact me easily through this forum. I am readily available to address this matter with you. You may click on "Personal Message" under my name and send me a message.

This open letter addressed to you is kept simple so that the issues are not confused. If you require further discussion to help you acknowledge your error and clear up this matter, I am available to assist you in clarifying the facts surrounding this situation. Given some recent occurrences within the Local Churches, I would believe it is essential to be clean before the Lord so that the enemy would not have any advantage against the Lord and His church among us.

If you are concerned about the open manner in which I am addressing this matter, please contact me directly and I will provide you with the support for my choice of this means of communication. Your brother in Christ,

## POST 3: A Question For Sandee Rapoport

1/9/06 - After hearing about what Benson had said at the 2005 winter training, my mom sent the following email to Sandee Rapoport. She had Sandee's email address because Sandee had purchased my mom's book off the internet:

Subject: FW: Your book mentioned in the training.

## Hi Sandee,

Did you and Max leave the Local Church in mid to late 1978? I have been asked about that period of time by some who have read my book and are seeking the truth about what happened during those years. This date is what I remember. Could you verify or correct it for me?

POST 4: Email correspondence with a brother:

1/9/06 - A Local Church brother who had read my mom's book attended the 2005 winter training. Afterwards, he sent her a question:

Did you realize this was the reason you were disciplined in the church? Can you give me more details about it? From your book, I got the impression that what was going on in Texas was unrelated to the west coast, but BP said it came from the west coast.\

1/10/06 - My mom responded to him with the following email:

Dear Brother,

Just recently I was informed by several others about what Benson said at the winter training. I will do my best to answer your question. My experience with the "sister's flow" was as I wrote about it in the book. I did not say much about the sisters' flow in the book because I had zero involvement with the Anaheim sisters' flow or the Texas sisters' flow. Here is a brief overview of the actual sequence of events related to the sisters' flow at that time, showing where I fit in the picture:

In early 1977, I heard rumor that God was doing something with the sister's in Anaheim from someone locally and mentioned this in a corporate sisters' meeting.

In May of 1977, I was condemned as the leader of a sisters' rebellion in Texas. The sisters' flow in Anaheim (led by Sandee Rapoport and two other sisters) was underway (and sanctioned by Witness Lee) until the summer/fall of 1978, when Witness Lee Aexposed" Max and labeled the sisters' flow as a Asisters' rebellion."

What Benson said at the Winter Training left the impression that I was dealt with in Texas after Brother Lee dealt with the Athree holy sisters" in Anaheim. He represented to the thousands of listeners that this was done after watching how Brother Lee dealt with these Afactious" sisters in Anaheim. I am sad to report that in his statement to the trainees, Benson bore false witness. What he represented is, plain and simply, not true.

What is the truth? I was dealt with in May 1977. Max and Sandee Rapoport (she was the main Aholy sister") were dealt with by Witness Lee and left the Local Church in the fall of 1978. The Anaheim sister's flow then became known as the Asisters' rebellion." (The Lord used Sandee and some other sisters to start this Aflow"Cone that I now believe helped marriages and families Yas your own experience with it testifies.) This flow did not come from Witness Lee, although for a period of time he sanctioned what these sisters were doing, probably because Max was at that time his new Aright-hand man." Brother Lee allowed this until he turned against Max when Max began to confront him about Phillip and the sin in the LSM office. Then, Witness Lee dealt with the Athree holy sisters."

I am 100% certain that I was disciplined in May 1977, because this happened a day or so before my husband's mother suddenly died on June 1, 1977. That date is a matter of public record. To the best of my knowledge Max and Sandee R. were "exposed" in the fall of 1978. The only written documentation that I have found which provides a date when Max and Sandee left the Local Church is the God-Men, by Neil T. Duddy. That book says they left in November 1978. (I am planning on sending an email to Sandee for date confirmation and will let you know what I learn. I do not know her personally but I have her email address. I emailed another question to her a month or so ago, and it took a long time for a response. I don't think they do much emailing. Anyway, I hope I hear from her.)

I have three independent memories that further confirm the sequence of events for me.

- 1) Not long after Dan Williams dealt with me, the leading brothers in Texas welcomed the sisters' flow from Anaheim to the Texas churches. It was sanctioned by them. I was never involved in this sanctioned Texas sisters' flow.
- 2) In July of 1977 (shortly after my Adiscipline" in May), John decided that because we were in such bad shape, we should attend a special July 4th weekend church conference in Anaheim and maybe get help from Witness Lee's sharing.

At this point, I believed that the problem in the Texas churches was with the elders in Texas misapplying

or wrongly implementing whatever they heard from Witness Lee. One day while we were there, the sister in whose home we were taking hospitality told me that we had been invited to lunch at Sandee Rapoport's house. The sanctioned sisters' flow under Sandee's guidance was underway in Anaheim. (i.e., Witness Lee had not yet stopped it.) After lunch, Sandee, whom I had never met before, took me aside into a private room and talked with me. She was warm and loving and seemed to be someone I could talk to about what we had been through.

Yet as she talked to me, I had a strong feeling not to mention my own situation at all. I had a witness that what she was sharing was of the Lord. I knew she was waiting for a response from me, but I said only a few words to her, just acknowledging I was listening. Afterwards, when I left, I had a tremendous sense of peace. As much as I wanted someone's sympathy and help, it seemed this wasn't what the Lord wanted for me at that time.

3) Approximately a year later, I heard about the "three holy sisters" being singled out in a meeting by Witness Lee. I remember this because being in the meetings at that time was such a suffering to me. When they began to "expose" Max in the meetings in Texas and announced the end of the sister's flow, calling it a "sister's rebellion," I clearly remember thinking that what had happened to me was now happening to Sandee R. and the other sisters there with her.

I still marvel that I didn't talk to Sandee that day at her house in 1977 and tell her everything. She certainly gave me the opportunity. (Matt, knowing me well, had a good laugh when I told him that he no doubt would realize that my silence at that time was probably one of the most powerful testimonies of Christ he would ever hear from me!) I remember thinking, after being at Sandee's home that day, how wonderful it would have been to have been able to fellowship freely with those sisters. They were seeing and experiencing together many of the things I had been realizing from the Lord.

But the point of all this is that Benson reversed the sequence of events when he talked about it in the winter training. I can only surmise that he may have felt the need to legitimatize the action taken towards me by linking it to Witness Lee's action, indicating that it was according to Witness Lee's example.

You asked if I realized this was the reason I was disciplined in the church. So, if by "this", you mean the Anaheim/Texas sisters' flows as Benson indicated, the answer is I did not get in trouble for being part of these. All I understood then was that they suspected me of some kind of subversive activity--starting from the time I made mention of hearing about a sisters' flow in Anaheim. However, as I explained in the book, I now believe that the real reason was that Satan was targeting my individual experience of the Lord. This is supported by the fact that their public condemnation included statements about seeking to be a spiritual giant and about reading books about "spiritual giants" (pp. 310-311). Sandra (my fellow "rebel") was asked to burn her Madame Guyon book for this reason...

One other point: It is also noteworthy that Benson used the words "factious" and "sectarian" in his condemnation of me at the winter training. These are not words used at all when I was dealt with in Houston. Rather, I was labeled as the leader of a sisters' rebellion. I consider his current emphasis on forming parties and being sectarian to be a re-writing of history colored by his memory of the Anaheim

sisters situation. I also wonder if he purposely avoided the use of the word "rebellious" because of Witness Lee's footnote on Matthew 5:22 which I had pointed out in letters I wrote in the early 1990s (pp. 257).

I hope this answers your question satisfactorily. Now, I have a question for you—are you positive you heard Benson say at the Thanksgiving conference that he was actually reading my book? I do hope that is so. I have heard reports that he never read my long letter to him written in the early 90s. Your sister in Christ,

1/11/06 My mom received the following email from another Local Church brother:

By the way, Dan Williams mentioned your book at the last Winter Training (of course, he did not mention your name). Whatever regrets he had for dealing with you harshly in the past, he dismissed them now. He said that they had dealt with you rightly, because if you were able to write the book against the recovery now, you must have had the seed of it then. I am sorry to tell you such unpleasant things. This brother did not read your book and still had liberty to judge you. He had no thought that he himself planted the seed and watered it. But I am happy that this seed, nonetheless, by the Lord's mercy produced sweet fruit. Your book doesn't have any bitterness. So it is not against the recovery, it is for the recovery. It recovers many wounded souls.

POST 6: Email correspondence between my mom and Sandee Rapoport:

1/11/06 Sandee responded to my mom's question about the date they left the recovery:

Subject: FW: Your book mentioned in the training.

Hi Jane, Yes we left Sept. 1978. Would love to stay in touch with you. Are you in Oklahoma or Texas. I will answer any questions you would like to know. I bet you're getting lots of feedback on your book. I'm praying for you . What did they say in the training? They still talk about us event to this day. Strange. God bless. Hi to your family. Sandee

1/12/06 In her reply to Sandee's email, my mom wrote:

Thanks for the information, Sandee. We are in Plano, Texas (a Dallas suburb). Thanks for offering to answer other questions.

I would like to hear about the "three holy sisters" incident if you wouldn't mind sharing it. That might be a job by email, so if you prefer, we can talk by phone when it is convenient for you. Let me know when a good time for you is. Weekends, probably Saturday, are the best time for me.

Thank you for your prayers,

Jane

## Sandee responded on 1/14/06:

..Max and I left in Sept. 1978 but the trouble started on Memorial Day, May 1977. I would be more than happy to share with you all that we passed through. The name "holy sisters" was given us by Philip Lee because of Max talking to Witness about the Living Stream trouble concerning Philip. He was very upset with us. I will call you and would very much love to spend time with you regarding all the Lord has done.

Your book was right on, for I found the Lord through it all even though those many years was a nightmare. Thank you again for sharing your experience. We have been able to touch the lives of many, many saints who left the LC and other groups with similar experiences. Sandee

1/15/06 My mom wrote Sandee again and sent her a transcript of what Benson actually said about the holy sisters at the training. She also asked Sandee another question:

Thanks for the reply, Sandee, and thanks for being willing to share the details of your story with me. One question now, approximately when did Witness Lee publicly call you all out as the three "holy sisters" in the meeting Benson referred to? I have guessed it was in mid to late 1978. Since I wrote this in my email to a brother, I would like to know that date if you know it, so that I can verify (or correct) my correspondence with this brother.

## 1/15/06 Sandy wrote back this surprising response:

Jane, There was no such calling out, about holy sisters. Benson must be speaking about the mid-age [middle-aged people] conference. That's when everything changed, and we stayed a year after that, but those were very strange times. Ann and Harriett and Max and I went to talk with Witness about how he lied about us and that our spirits were offended. He never came to talk face to face with us. He discredited us when we had been in fellowship with him and the elders through it all. He just listened and did not say a word. That was his way. Max and I were very close to Witness. It was not our choice to leave. We thought we would be there forever until the Lord came back. We were pushed out through lies that were brewing over that time. A brother has a short testimony from each of us, but it's not the whole story. In His love, Sandee

POST 7: Another question from a brother and a phone call with Sandee:

1/17/06 On this morning, my mother received another question in an email from another Local Church brother:

I have one question. At the last winter training, Benson told the story of how Brother Lee openly had dealt with three "holy" sisters at one of his trainings. Were you present at that meeting? Can you tell me the details?

1/17/06 That evening Sandee called my mom and they talked for about an hour and a half. The following is from notes my mom took during their phone conversation. It also includes her thoughts about what she learned from Sandee and a surprising discovery.

Sandee told her that Benson's statements at the winter training could only have referred to the Memorial Day weekend conference in 1977. While the young people were at a conference in Berkeley and Max was at a conference in Chicago, Witness Lee held a special conference for middle-aged saints in Anaheim. Sandee said that at that conference, out of the blue, Witness Lee began to speak disparagingly of the sisters. Sandee was positive that Witness Lee did not call them "holy sisters" (this was the only time he spoke about them publicly). He also definitely did not address them directly nor ask them to stand up.

My mom was struck by the date Sandee told her. She told me that she could hardly believe that this could be the correct date (Memorial Day weekend, 1977) and repeatedly asked Sandee if she was sure it was 1977. Why was my mom shocked by this date? This was the exact same weekend that she was dealt with as the leader of the sister's rebellion in Texas! (My mom said it happened to her on Saturday night. Sandee said Witness Lee did this to them also on Saturday night.) My mom had always thought that the "sisters' rebellion" in California was dealt with in late 1978 because that was when the Texas brothers announced the end of the sisters' flow in Anaheim and called it a "sisters' rebellion."

Sandee was positive about this date (Memorial Day, 1977). She said it was the same weekend as the notorious Berkeley conference where the young people went wild and did a number of crazy things. Sandee remembers clearly that on that same weekend, when Max was at a conference in Chicago, he received a call telling him to come home quickly because of what Witness Lee had said publicly about the sisters. Whoever called him was concerned for Sandee.

Witness Lee did not say anything about a sisters rebellion. He only spoke in a way to put a question mark over what had been going on with the sisters, mainly by saying that those involved should not sit together but take care of other sisters and sit with them.

This came as a complete surprise to Sandee, Ann, and Harriet because Witness Lee had been completely supportive of what they were doing with the sisters for several years prior to this. He was fully informed, as were all the local elders, about whatever was happening. He constantly encouraged Sandee to do whatever she felt led by the Lord to do with the sisters. He even allowed her to minister the Word in sisters' meetings. Sandee, Ann, and Harriet were fully one with Witness Lee and were praying about and practicing whatever he ministered.

They were all stunned that he would speak publicly and critically about things related to the sisters in the church without having first talked to them in private. From that time forward, Sandee said everything became really strange. (My mom also asked Ann about this conference meeting, and she said exactly the same thing as Sandee. She said they were not singled out, nor were they called "holy sisters" by Witness Lee. Ann said she also remembers him saying something about the fact that he had not appointed them.) Sandee said she was stunned when Witness Lee began speaking like this. She said that God's grace came upon her while this was happening. She heard what Witness Lee said, but she felt shielded from the hurt of it.

At the end of the meeting Sandee stood and said she was sorry that there were some people that were upset with them. (She didn't "repent" because she could not repent for something of which they were not guilty.) Sandee continued saying that she was one with Brother Lee and the ministry and would make any turns Brother Lee made and support whatever flow was happening.

Sandee told my mom some more background regarding the time prior to this conference on Memorial Day weekend, 1977. She said that the elders in Anaheim made Ann, Sandee, and Harriet leading sisters in 1974. They encouraged them to pray for and get with sisters who were struggling.

The elders, in particular Max, were doing the same for the brothers. These three sisters met with the elders weekly and told them whatever was happening with the sisters. Everything they did was fully "covered" by the elders in the Church in Anaheim.

This went on for several years with Witness Lee constantly very supportive. There was never any such thing as an independent "sister's flow". What happened with the sisters there (clearing up problems with one another, etc.) was normal and spontaneous over a period of time and was done in conjunction with Witness Lee's ministry.

Sandee had not one clue there was any problem whatsoever until Witness Lee spoke disparagingly about the sisters publicly. She told my mom that she and Max were very, very close to Witness Lee. They were with him many times during the week eating and fellowshipping with different brothers and sisters. They were always with him when bringing important people into the church from other groups.

Sandee found his first apartment for him in Anaheim and helped him move in to his new place. She took him to the eye doctor and hospital, etc. He asked her to pray for his wife and anoint her with oil when she was sick. He asked her to talk with his daughter before her wedding and have those close to her help with the wedding. Max and Sandee loved doing these things for him.

Witness Lee called Max every morning at their home and was with him every day for fellowship about church and family matters. (This made what he did to them starting Memorial Day Weekend, 1977 even more painful.)

A few weeks after what Witness Lee said at that weekend conference, Sandee, Ann, and Harriet went to talk to him about this. Again, he did not say such a thing as "holy sisters" to them or treat them in a bad

way. Sandee said that they later realized the change toward them which he first demonstrated at the Memorial Day, 1977, mid-age conference was a result of Max having talked to Witness Lee about Philip Lee being caught with a sister in the LSM offices. (Max had done this not long before the Memorial Day 1977 conference.)

Sandee said that the "sisters' flow" continued in Anaheim after the Memorial Day weekend, 1977, until the next year when she and Max were eventually forced to leave. However, she said that after that weekend, things were never the same as they had been during the years before. She said that one time after the Memorial Day weekend conference, a sister whom she was close to came and sat by her in the meeting. Sandee, remembering what Witness Lee had said about not sitting together, turned to the sister and said, "You had best not sit beside me."

The sister moved. Sandee said that immediately the Lord spoke to her that this was wrong! She went and told the sister she was wrong to have told her where she could sit. She said that night after the meeting, she went home to Max and cried saying something to the effect that she was having a big problem because Witness Lee was saying one thing, and the Lord was saying something different to her. She also said that some of the sisters became upset by what Witness Lee said at the mid-age conference and stopped coming to some of the meetings.

After that weekend, Sandee spent much of her time trying to help with all the problems that were begun as a result of what Witness Lee said. She also told my mom that a very strange thing happened after that conference. Witness Lee asked Max to box up all of Sandee's books and bring them to him! Sandee could not believe this. She told my mom that after being saved, she read three books that had a big impact on her walk with the Lord: Rees Howells, Intercessor; Madame Guyon; and Song of Songs by Watchman Nee.

Sandee learned about other biographies of ones such as Amy Carmicheal which were out of print. She had them reprinted for the sisters there to read. These kinds of books were what Max took to Witness Lee. After about a week, he returned them. Sandee believes he wanted to see what other books the sisters were reading, though this was never said to her.

After the phone call with Sandee, my mom was very bothered. She told me that she simply could not quit thinking about the fact that what Witness Lee began to do to Sandee, and what happened to her, were on the very same weekend! How could this be? Intuitively she knew that this was significant. It certainly was not as Benson portrayed in the winter trainingCthat he saw Witness Lee call out the "holy sisters" and that they then had to do something in Texas. No, it was not that way at all. What was done was done on the same weekend!

## 2/16/06 -- My mom discovers that Benson's false statements are in print.

On this date my mom received the edited and printed version of Benson's statements which appeared in

the LSM Ministry Magazine shortly after the 2005 winter training. When she compared the transcript of Benson's spoken words to the printed version (pages 291-292, Ministry Magazine) she noticed some differences. The printed version was edited, but remain basically the same. Some differences are:

- 1. The printed version no longer has Benson saying "I remember" nor does it have Benson saying, "I think he said for them to stand up."

This is what I'm choking on. If there is any way that you could take this information and say that Benson misspoke, then I think you could bring it to his attention, even privately. Any responsible adult, much less one who claims the status of he who is "becoming God" would be horrified at his mistake and correct it immediately, on his own, without being asked. You don't even have to be a Christian to correct a mistake. You just have to have a conscience.

Here is an example of a mistake Benson made: "In 1987 we had some sisters out on the west coast...." In fact, it was 1977-78. He got the date wrong, yet later said 30 years ago, so he corrected himself. This kind of statement can be called a misspeaking.

When a Christian prepares a sermon that includes examples or "stories" about real people, and the effect of the stories will be to prolong thirty-year-old accusation against members of the Body of Christ, what is that Christian's responsibility for accuracy? They must be accurate before God, accurate before those being accused, accurate before the audience of thousands present at their speaking, and accurate before those whom their "stories" will eventually reach through the print medium. If a Christian preacher is going to speak negatively about a book, does he have the responsibility to read the book first? This was no "misspeaking". Benson prepared his stories. He prepared five carefully crafted lies:

#1: Benson indicated that these two events happened at different times, and clearly, they did not.

#2: Since both events happened on the same night, Benson did not receive his "inspiration" in a meeting he did not attend.
